### Programs & Services

#### S.O.S. (Safe Overnight Stay) SHELTER

Community of Hope, in partnership with the Brevard Homeless Coalition Inc., offers a very short-term shelter program called S.O.S. (Safe Overnight Stay). This program is for families who are unexpectedly or suddenly experiencing homelessness, particularly for the first time. There are two location for this program, one in South Brevard (Melbourne) and one in North Brevard (Titusville). In order to access our S.O.S. program, a family must call and be referred by 2-1-1.

#### **Transitional Housing Program**

The Transitional Housing program fills the gap between emergency housing and long-term housing. We provide transitional housing units which provides a stable housing solution for up to two years. These units are available to working families with (minor) children who meet the criteria for entry and demonstrate a likelihood of success if given low-cost housing and supportive services.

#### Permanent Supportive Housing

This program provides long-term subsidized low-cost housing to families that would otherwise be unable to afford it. These include families who are saving for the down payment of a house, going to school while working, or taking care of older children who have long-term needs.

#### **Reunification Program**

Through a partnership with Brevard Family Partnership, Community of Hope works with case management professionals to provide housing for parents for whom it is the only thing left for parents to secure before being reunited with their children who are is



reunited with their children who are in the care of others by court order.

Community of Hope is a local nonprofit organization that seeks to end family homelessness in Brevard County. They work with families of all types, especially those with minor children, to find housing solutions that fit their needs.

#### **Hope Housing Services**

Hope Housing Services allows Community of Hope to provide funding to move families into rental housing and provide the support needed for them to stay there. Funding for the initial expenditure comes from generous giving from the community and donors. Grants reimburse only what is spent to get the family into housing. In Brevard it can cost over \$3000 just to move into an apartment. Many working families can't do that alone.



## **BREVARD COUNTY RESIDENTS**Financially Impacted By Covid

Rent / Utilities / Mortgage / Hotel / Burial

Brevard County has \$18 M for housing funding to help those financially affected by the COVID-19 pandemic (**Indirectly or directly affected- all self reported**). This assistance is for rent/rental arrears, utilities and home energy costs/costs arrears, other expenses related to housing, and burial.

**CHANGES:** The income limit is more generous than past funding and there is no case management component. The county has been trying to make this process less challenging to be able to help more people and get the available resources out to people who need it.

#### **Assistance Kev Points:**

- The applicant must 'self-certify' to direct OR indirect COVID-19 cause of situation; which could be a loss of hours or increase in overall expenses due to Covid-19 price increases, or changes made due to the pandemic that cause financial hardships.
- Applicants do not need to be literally homeless.
- Funds may be used for delinquent rent, as well as up to 3 months of prospective rent.
- Applicants can 're-certify' their eligibility with a (not-yet-created shortened application) at the end of the 3 months of prospective rent and may be able to get another 3 months of prospective rent.
- This funding will also pay for hotels if hotel agrees to 30 days of stay.
- Applicants may be self-pay at hotel/motel and, as long as the hotel/motel will 'bill out' a month in advance.
- Room rentals in doubled-up situations may also apply as long as there is a lease.

#### **Application Key Points:**

- Income verification is a 1040 from 2020 tax year.
- A FULL COPY of a valid lease in the name of the applicant is required.
- Require W-9 from Landlord If you are having issues with obtaining this, please call 321-633-2007 to find out what you can do. (It has been "said" that the landlord can provide phone number for them to call to get this information from he/she directly, **BUT** call to verify)
- ALL documentation must be provided at time of submission for the application to be considered, or application will be denied.
- Full process takes about 4 weeks.

#### RENT / UTILITY ASSISTANCE

Eligible Florida renters can qualify for **up to 15 months of rent and utility payments.** This includes 12 months of past due rent and utilities and three months of forward-looking rent payments.

• Renters who are at risk of eviction should speak to an attorney to understand their rights and what to expect while they apply for rental assistance. #### **ELIGIBILITY**

#### YOU ARE ELIGIBLE IF YOU:

- Rent your home, apartment, or other residential dwelling in Florida.
- Earn an income at or below 80% of the area's median income (AMI).
- Have qualified for unemployment, experienced a loss of income, incurred significant costs or faced financial hardships due to the COVID-19 Public Health Emergency.
- Are at risk of losing your home, experiencing housing instability or are living in unsafe or unhealthy conditions.

#### **DOCUMENTATION**

IF YOU ARE A RENTER, COLLECT ALL OF THESE DOCUMENTS THAT APPLY FOR ALL MEMBERS OF YOUR HOUSEHOLD:

- Identification, such as driver's license, birth certificate or passport.
- Current lease agreement or other proof of rental arrangements, such as receipts, bank records or canceled checks that show a pattern of rent payments.
- Documentation of annual income, such as 2020 tax filings, a W-2 or 1099 from your employer, or other proof of income; or documentation of monthly income, such as pay stubs, bank statements, income certification for housing subsidy, or other proof of income.
- If you qualify for SNAP, TANF, Medicaid, subsidized housing or lowincome housing, proof of eligibility documents.
- Documentation of unemployment benefits or proof of reduction In household income or proof of increased costs (medical expenses, childcare, transportation) due to the COVID-19 Public Health Emergency.
- Notice of past due rent, lease termination or eviction, or condemnation order or failed inspection report from local government.
- All payments for utilities and home energy costs must be supported by a bill, or invoice in the name of the tenant reflecting the address for each qualifying utility for a period after April 1, 2020.

#### FREQUENTLY ASKED QUESTIONS:

#### INCOME LOSS

HOW DO I PROVIDE PROOF THAT I LOST INCOME DUE TO THE COVID-19 PUBLIC HEALTH EMERGENCY?

- Letter from employer stating reduced wages
- Notice of business closure; Termination or layoff notice
- Proof of wages prior to 3/13/2020 and wages after 3/13/2020 (at least three pay periods) showing reduction
- Proof of loss of child support; Proof of loss of spousal support
- Employer attestation indicating reduction
- Proof of routine cash deposits prior to 3/13/2020 and after 3/13/2020 for individuals with cash income

## COSTS DUE TO COVID

HOW DO I PROVIDE PROOF THAT I INCURRED SIGNIFICANT COSTS DUE TO THE COVID PANDEMIC?

- Treatment for the COVID-19 Public Health Emergency
- Actions taken to prevent infection
- Costs for relocation due to financial or health circumstances
- Purchases to support remote work or school
- Childcare needs due to school closure
- Cost of alternative transportation
- Increase in utility costs; or Penalties for late rent or utilities.

Applicants must provide verification for expenses, such as: Receipts for purchased items; Medical bills; or Proof of utilities prior to 4/1/2020 and utilities after 4/1/2020 (at least three bills) demonstrating an increase.

#### **IDENTIFICATION**

Unused or expired prescription medications are a public safety issue, leading to accidental poisoning, overdose, and abuse.

Pharmaceutical drugs can be just as dangerous as street drugs when taken without a prescription or a doctor's supervision.

The non-medical use of prescription drugs ranks second only to marijuana as the most common form of drug abuse in America.

The majority of teenagers abusing prescription drugs get them from family and friends—and the home medicine cabinet.

Unused prescription drugs thrown in the trash can be retrieved and abused or illegally sold. Unused drugs that are flushed contaminate the water supply. Proper disposal of unused drugs saves lives and protects the environment.

Take-back programs are the best way to dispose of old drugs. But if a program is not available:

- · Take the meds out of their bottles;
- Mix them with something unappealing like used kitty litter or coffee grounds;
- Seal them in a bag or disposable container, and throw that away.

### **Services Offered In Brevard County**

#### **Family Support Services**

Eckerd Connects' Family Support Services provides case management and financial assistance through rapid re-housing to children, families, and individuals who have an identified history of substance use and are currently experiencing homelessness or are at imminent risk of homelessness in Brevard County. Our rapid-rehousing program helps with move-in assistance, rental assistance and case management.

#### **Supervised Family Visitation**

Eckerd Connects' Supervised Family Visitation program provides short-term therapeutic and standard supervised visitation services to families that are court-ordered through dependency and family court. Parenting classes and additional private-pay supervised visitation services are also available.

#### **School-Based Prevention Programs**

Our School-Based Prevention Counseling and School-Based Prevention Hi-Five programs have Prevention Specialists at schools providing classroom, group, and individual services with the goal of increasing protective factors against substance use. These Prevention programs utilize evidence-based curricula to focus on strength-building and substance use prevention. Lessons are taught weekly, and sessions are designed for grades 3-6 and 6-12.

#### **Raising Hope Program**

The Room of Hope has clothing, hygiene kits, infant needs, school supplies and other essentials which are provided to families in transition as well as children who were recently placed in the foster care system.
